Subject: Consolidated Scrutinizer's Report on remote e-voting pursuant to the provisions of Section 108 of the Companies Act, 2013 read with Rule 20 of the Companies (Management and Administration) Rules, 2014 and amendments thereto and voting through Ballot Papers at the AGM venue at the 74th Annual General Meeting of M/s. Neelamalai Agro Industries Limited, held on Thursday, August 17, 2017 at 12.00 Noon at Katary Estate, Katary Post, Coonoor, The Nilgiris – 643213.

I, V Suresh, Practising Company Secretary, have been appointed by the Board of Directors of M/s. Neelamalai Agro Industries Limited (the Company) as the Scrutinizer for the purpose of scrutinizing the remote e-voting/ voting through Ballot Papers at the AGM venue and ascertaining the requisite majority, as per the provisions of Section 108 of the Companies Act, 2013 (the Act) read with Rule 20 of the Companies (Management and Administration) Rules, 2014 and amendments thereto in respect of the resolutions contained in the notice to the 74th Annual General Meeting (AGM) of the members of the Company, held on Thursday, August 17, 2017 at 12.00 Noon at Katary Estate, Katary Post, Coonoor, The Nilgiris – 643 213.

The Notice dated 30th May 2017 was sent to the Shareholders in respect of the below mentioned resolutions passed at the Annual General Meeting of the Company.

The Public Advertisement with respect to dispatch of notices and conducting of voting through electronic means was published in an English newspaper "The Financial Express (Chennai Edition)" and in a vernacular newspaper "Makkal Kural (Coimbatore and Chennai Editions)" having wide circulation, on 26.07.2017.

The management of the Company is responsible to ensure the compliance with the requirements of the Companies Act, 2013 and the Rules relating to voting through electronic means on the resolutions contained in the Notice of 74th Annual General Meeting (AGM) of the members of the Company. My responsibility as a Scrutinizer for the e-voting process is restricted to presenting a Scrutinizer's Report on the votes cast "in favour" or against or "abstained", in respect of the resolutions stated below, based on the reports generated from the e-voting system provided by M/s. Central Depository Services (India) Limited ('CDSL'), the authorized agency to provide e-voting facilities, engaged by the Company.



The members of the Company as on the "cut-off" date i.e. August 10, 2017 were entitled to vote on the resolutions (items no. 1 to 4 as set out in the notice of the 74th AGM of the Company.)

Further to the above, I submit my report as under:-

### Remote E-voting:

- i. The e-voting period remained open from Monday, August 14, 2017 (9.00 a.m.) to Wednesday, August 16, 2017 (5.00 p.m.) (both days inclusive).
- ii. The votes cast under remote e-voting facility were thereafter unblocked in presence of two witnesses who were not in employment of the Company.
- iii. The Corporate member who had participated in the remote e-voting had provided scanned copy of the resolution passed at their Board of Directors Meeting for authorization to exercise their votes through e-voting.

## Voting through Ballot Papers at the AGM venue:

 The shareholders present at the meeting had already cast their votes through remote e-voting. So, there was no necessity for voting through ballot papers at the AGM venue.


